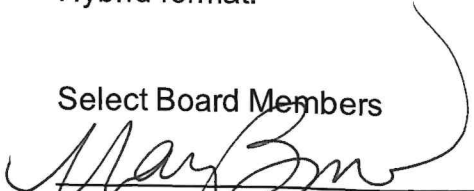
**Public Comments.**

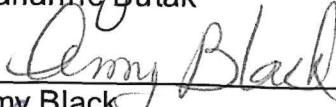
- Jim Van Colt: Why can't we put a Moratorium on business into place?

- Betsy Clark: If there are things in the campground ordinances that need to be rewritten does the Planning Board or the Select Board address those rewrites?

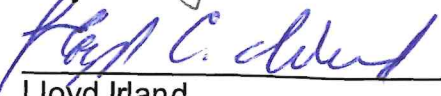

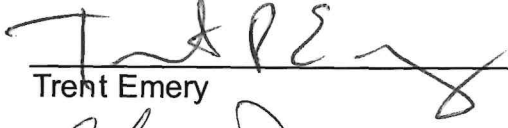

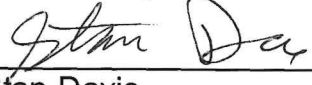
